

## Consent to personal data processing

This document defines the terms of receipt and processing by the copyright holder of the [karmann-group.org](http://karmann-group.org) website (the "Site") – Limited Liability Company « K R M N Information Technology » (K R M N Information Technology LLC), location address: Dubai, King Majid Sultan Abdul Rahman Saif Al Shamsi - Al Muteena - Bur Dubai F6 LG, Office 1, UAE (the "Operator"), the personal data of the user who accesses the Site and its services (the "User"). The User provides the Operator with its personal data in accordance with Federal Law No. 45 of 2021 on Personal Data Protection (PDPL) in the UAE.

№ 45 «Protection of Personal Data (PDPL)» by filling in special fields in the forms of services posted on the Site, including the feedback forms, and/or by informing the Operator of his personal data in other ways (including those communicated additionally by phone, in the process of using the Site). The User fully accepts the terms of this Consent to personal data processing (hereinafter "Consent") by filling out the relevant feedback form and/or by using the services of the Site and/or the Site as a whole.

The user gives his consent to the operator to process his personal data under the following conditions:

1. Consent is given to the processing of all personal data (including, but not limited to: surname, name, patronymic, address, date of birth, phone number, email address) posted by the User on the Site and/or otherwise communicated to the Operator, as well as data collected by web analytics systems Yandex.Metrika, Google Analytics, Facebook, Roistat and CoMagic (list of such data is posted on the site of the corresponding web analytics system).
2. The user confirms that all the data he specified belong to him personally. In case of indicating false (inaccurate, unreliable) information, as well as in case of untimely change of outdated information, the User shall bear the risk of any negative consequences caused by indicating incorrect information. The User confirms and acknowledges that he has carefully read the Agreement and the terms of processing of his personal data, the text of the Agreement and the terms of processing of personal data he understands; the User expresses his consent to the processing of personal data without reservations and restrictions. The User confirms that by giving Consent, he/she acts freely, of his/her own free will and in his/her own interest.
3. Processing of personal data is carried out by the Operator in order to: 1) using the Site and the Site's services by the User; 2) identifying the User of the Site; 3) providing communication between the Operator and the User through the personal (contact) data provided by the User; 4) providing "Feedback" service to the User; 5) monitoring and improving the Site; 6) conducting statistical and analytical research, user activity analysis; 7) improving service quality and conducting marketing programs and promotions. The Operator shall process personal data in the manner and on the terms stipulated by the approved Personal Data Processing Policy.
4. In the course of processing, the following actions may be performed with the User's personal data: 1) receiving, input, collection, systematization, accumulation of personal data by the Operator, as well as from third parties; 2) storage of personal data (electronically and in hard copy); 3) clarification (update, change) of personal data; 4) use of personal data; 5) transfer of personal data in the manner prescribed by UAE legislation; 6) blocking, removal, destruction; 7) any other actions (operations) or set of actions (operations) with personal data, performed with or without use of automation means

The operator has the right to transfer and/or assign the processing of the User's personal data to third parties (on condition that the regime of personal data confidentiality is observed, and on condition that it

does not violate the User's legal rights and interests, and the provisions of the current legislation). Third parties engaged by the Operator shall process the User's personal data provided by the Operator to the extent, for the purposes and by the means set forth in this Consent.

5. This Consent applies to all information that the Operator can get about the User during his use of the Site and its services. Using the Site and its services means the User's unconditional consent to the terms of processing their personal data, including through the use of web analytics systems Yandex.Metrika, CoMagic, Facebook, Google Analytics and Roistat. In case of disagreement with these terms, the User must refrain from using the Site and its services.
6. The User's consent to the processing of personal data is specific, informed and conscientious.
7. This Consent of the User shall be considered executed in simple written form. The Consent is valid indefinitely from the moment of providing the data and can be revoked by the User by submitting a written application to the Operator, specifying the data defined by Article № 45 "Protection of Personal Data (PDPL)". If the User withdraws his consent to the processing of personal data, the Operator may continue the processing of personal data without the User's consent, if there are grounds to do so.
8. The Operator shall have the right to amend this Agreement at any time. When making changes to the current edition, the date of the last update shall be specified. The new version of the Agreement comes into force from the moment of its posting, unless otherwise stipulated in the new version of the Agreement.
